Heatstroke

In hot climates, which can include many more areas of the northern US these days than before, heatstroke is not unusual. Heatstroke is the inability of the body to regulate internal temperature through normal means, such as sweating, when exposed to extreme heat. Body temperature can reach as high as 106 degrees farenheight, can result in prostration and even death, after as little as10 to 15 minutes of exposure. The elderly and the very young are the groups most susceptible, but all age groups are potentially at risk.

Symptoms can include confusion, slurred speech, loss of consciousness, hot dry skin or, at times, profuse sweating, light headedness, and seizures.

What do you do for the victim? Call 911 for expert assistance. Move the victim to a cool dry place if possible, or at least to a shaded area. Remove outer clothing. Cool the victim with ice to the head, arm pits, and groin areas if possible, or wet the victims clothing and exposed skin with cool water. Use a cool bath if available. Fans can be used to cool the victim if air conditioning is not available. If the victim is able to drink, administer oral fluids.

How is heatstroke prevented? First, in extremely hot conditions, remain in air conditioning, if possible. If you must go out, wear cool clothing, and drink plenty of fluid. Keep in mind that alcohol is dehydrating, and is a poor choice for hydration in hot conditions.. Don't forget sunscreen. Fluid intake should begin before going outside and should continue while exposure to hot conditions continues. If possible, gradually adjust to hot conditions by starting with short exposures, with gradual increases over time. If, while you're outside, you begin to feel ill, return to a cool environment as quickly as possible.

Covid

The CDC is recommending that persons over age 65 and persons with compromised immune systems receive 2 doses of the 2024-25 Covid vaccine, the second dose 6 months after the first. The first dose should be received now if not already taken.

This recommendation stems from the fact that immunity from vaccination wanes 4-6 months after administration. Also, as you may already know, the type of virus that is circulating changes rapidly, making the current vaccine less effective. It's important to point out, however, that the vaccine continues to protect from serious Covid infection, and from hospitalization and death.

On another topic, bird flu has been reported in about 35 people in the United States so far. I would suggest that you continue to avoid wild animals, alive or dead. Importantly, human to human transmission has not been reported.
